Honoring ARC (Access, Resource, Choice) of San Antonio and Jack Minter



John A. Minter has worked in the field of rehabilitation, psychotherapy, intellectual and developmental disabilities, and behavioral counseling services for over 40 years. He graduated from South Dakota State University with a Master of Social Work degree. He also holds a Master of Social Work degree from Tulane University. John retired from the USAF as a Lieutenant Colonel.

John became the President and CEO of the ARC of San Antonio in January 2006. Prior to his current position, John had served as President of Minter and Associates, P.A. providing Employee Assistance Programs in San Antonio and many other areas, Psychiatric Social Counselor, Staff Officer of the USAF Surgeon General's Office and Social Work Department. He has authored many articles in the related professional publications, and is licensed as a LCSW and NASW.

John resides in San Antonio with his wife. They have four grown children. He is also a licensed sport pilot.

Public Servant, Judge Nelson Wolff



Nelson William Wolff has been dedicated to making participation in government accessible to the people throughout his entire public career. Access, physically, virtually, and in every way has been a theme of his service which spans four decades.

Throughout his lifetime in serving the public, Judge Wolff has led the efforts in the construction or reconfiguration of many public facilities in San Antonio and Bexar county, always, with the advocacy and implementation of the accessibilities for all people. "People remember us for what we build, and what we build needs to serve everyone", says Judge Wolff. Although there is only one facility that has been named for Judge Wolff, the baseball stadium constructed during his days as Mayor of San Antonio, many other buildings and public projects bear his imprint. For each of them, accessibility by those with disabilities has been a high priority.

He was appointed Bexar County Judge in 2001 and has since been elected to the position in November 2002 and again in 2006. Judge Wolff also served as Mayor of San Antonio, State House Representative, and Texas Senator.

Wolff holds a bachelor of business administration from St. Mary's University and a doctorate of jurisprudence from St. Mary's University School of Law. Throughout his life, Wolff has excelled in both politics and business; he formed the Alamo Enterprises Building Supplies, Sun Harvest Farms, and recently, Green Fields Market.

Judge Wolff authored four books, together he and his wife, Tracy, have six children. The couple guided the effort to restore the Bexar County Courthouse through the Hidalgo Foundation.

Chris and Eddie Canales, Gridiron Heroes



Gridiron Heroes Spinal Cord Injury Foundation was formed in 2003 with a specific mission, to provide immediate, as well as, long term resources and support to individuals sustaining catastrophic spinal cord injury through activities associated with high school football.

On November 2, 2001, Chris Canales, a senior defensive back playing for San Marcos Baptist Academy, sustained a spinal cord injury during the fourth quarter of his final regular season game. Chris lay motionless on the field for 19 minutes. The next three weeks, Chris fought for his life. The following months he battled through rehabilitation trying to gain movement and learning how to function as a quadriplegic. Chris' injury and the lack of any organized support system for families prompted his father, Eddie Canales, the Canales family, and former coach Mike Kipp to begin the founding of Gridiron Heroes, a desperate need of an organization to help families who were forced to deal with the consequences of this devastating injury.

Receiving calls from other states, Gridiron Heroes has taken step towards helping others nationwide. There have been others who suffered this similar injury in the past, unfortunately and inevitably there will be more. Gridiron Heroes will be there for the next family who finds themselves in this life-changing situation.

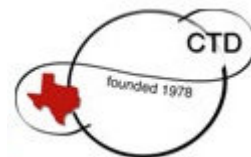
