

Elsa's always looking for a story that affects San Antonio at the street level, so she launched "Elsa's Angels" that spotlights people who give selflessly although may need help themselves.



Public Servant Award: Judge Marion T. Carson

Keynote Speaker: Roberto "Bobby" Barrera



Judge Carson has been a Municipal Court Judge since 1984 and manages his own private practice. Judge Carson is a graduate of St. Mary's University and obtained his law degree from St. Mary's University School of Law. Judge Carson, who lost his hearing in an accident, uses captioning (CART) services, interpreters and uses computer based software to facilitate communication while on the bench.

An accomplished individual, Judge Carson has served as a litigator, counselor and civic speaker. In 2009, he was the recipient of Deaf Interpreter Services' "Outstanding Achievement Award". He has been a gubernatorial appointee, served on multiple planning councils, written various charters, and is a Director Emeritus of the San Antonio Livestock Exposition (rodeo). Judge Carson is also licensed to practice before the Supreme Court of Texas and three Federal Courts.

Honoring Army Fisher Houses

Two years later, the first Fisher House at Brooke Army Medical Center, Fort Sam Houston, TX opened in 1992.

In 1995 Fisher House II at Brooke Army Medical Center, San Antonio, TX opened.

By 2007 more than 3,000 guests, including some 300 wounded service members, attended the Brooke Army Medical Center ceremony on January 29th that marked the opening of Fisher Houses III and IV (number 36 and 37), increasing the capacity at the Center from 15 to 57 and the Center for the Intrepid.

SAILS is honoring BAMC Army Fisher Houses as the veteran organization of the year.



Roberto "Bobby" Barrera, a U.S. Marine Corps combat disabled Vietnam War veteran was the National Commander of the 1.2 million-member Disabled American Veterans (DAV) in 2009. He also served as Chairman of the DAV Board of Directors for one year in 2010.

On September 16th, while serving with the Marines in Vietnam, he was seriously burned when enemy forces exploded a 500-pound bomb rigged as a land mine beneath the armored personnel carrier he was traveling in. Besides his face, over 40 percent of his body was also burned, he lost his right hand at the wrist and his left arm at the shoulder.

Bobby battled courageously to overcome numerous physical and mental obstacles. He earned his bachelor's degree in psychology at St. Mary's University, and later, a Master of Education degree in guidance and counseling at Sul Ross State University.

In addition to teaching high school, Bobby's career has included the position as the Director Family Support Center at Laughlin Air Force Base in Del Rio. He currently conducts motivational presentations for the Department of Veterans Affairs.

Bobby is the recipient of numerous honors and awards. They include: Purple Heart Medal, National Defense Service Medal, Vietnam Service Medal, Vietnam Campaign Medal and Combat Action Ribbon, the DAV Outstanding Disabled Veteran of the Year for 1998; LIFE's (Leaders In Furthering Education Foundation) Presidential Unsung Hero Award for 1998; Disabled Veteran of the Year for the State of Texas in 1990 and again in 1998; and Department of Defense Outstanding Employee with a Disability Award for 1997. The late Jesse Brown, Secretary of the Department of Veterans Affairs, selected Bobby's personal story of overcoming disability for inclusion in his book, "The Price of Their Blood." In 2005, Oliver North included Bobby's story in one of his television series, "War Stories with Oliver North."

A life member of DAV Chapter 5 in San Antonio, Bobby and his wife, Maricelia, reside in Del Rio. They are parents of three grown children and grandparents to four grandchildren.
