# Message from SAILS' Executive Director: Kitty L. Brietzke, J.D. How Will Government Budget Cuts Impact Services to People with Disabilities?

All levels of government are tasked with making some tough decisions about budget cuts in an attempt to balance the budget. If you work for a nonprofit organization, if you are a teacher or a caseworker; you should be concerned about the far-reaching cuts. Everyone should be concerned about the government's proposed cuts because at some point everyone will be impacted.

I stated in the last issue of this newsletter that San Antonio Independent Living Services (SAILS) maintained a financially strong fiscal year 2009/2010 through continuation of federal and state grants. I stated that 2011 promises to be even better. However, since SAILS receives volumes of funding from both the state through the Department of Assistive and Rehabilitative Services (DARS) and from the federal government through the Department of Education's Rehabilitation Services Administration (RSA) funds, it is quite evident that that families with disabilities who depend on SAILS programs that are funded

through this government money will certainly suffer the most.

Just how will proposed cuts impact people with disabilities? For example, if there are cuts to Medicaid then people who need durable medical equipment such as walkers, accessible bathroom equipment, and mobility devices may not be able to receive the assistance they need. What about the impact to people who are aged and disabled and still live in their homes? They depend on community-based programs so they can live a quality life in their home of choice without being forced into institutional care. People who have a need for vision and hearing services will be impacted too. But, all this is the tip of the iceberg! I know we all need to do our part to "tighten our belts" but let's not forget that many of these programs and expenditures are funded to prevent even more government expense in the future. For example, the Children's Health Insurance Program (CHIP) provides much needed dental care to children. Children who receive dental care regularly under this program will have less cavities and better overall dental health. Without CHIP what will really be the cost to society? Aren't we just going back to an emergency room mentality?

In closing, SAILS depends on funding from our state DARS and from RSA to provide services to people with disabilities to assist them with leading an independent and productive life. We will continue to ask the members of our local, state and federal government to not cut the center for independent living programs. SAILS will continue to advocate for no cuts that impact our people with disabilities. SAILS will also strive to diversify funding and seek those generous donors who are interested in helping people with disabilities to live more independently and self-sufficiently, turning disabilities into abilities.

Kendall began working odd jobs with his brother Randall. The Department of Assistive and Rehabilitative Services helped him with hearing aids and getting the tools he needed to get back in business. He received benefits counseling from me and I reassured him that he would not lose his benefits. Mr. Christian is currently working, and he knows that being an air-conditioning and heating technician is the direction he wants for his life.

In addition to problems with the phone, he was using an old hearing aid that no longer worked for him. Lori advocated for him to receive another phone with more amplification due to his change in disability. She, also, referred him to the "Hear Now" program to assist him in purchasing a new hearing aid.

2011 is going to be a good year for Mr. Burrows. He has two new "state of the art", digital hearing aids and a new telephone! He reported to Lori that he had a good experience with the "Hear Now" program and is thrilled that STAP approved his new phone. He expressed much gratitude to SAILS for assisting him with both needs. He says that he is hearing things he never heard before, although, there is some drawback to that. He said his screen door is squeaking and he never knew his truck rattled so much!
