On July 26, 1990 President George W. Bush signed into law the most comprehensive piece of legislation ever written for persons with disabilities-The Americans with Disabilities Act (ADA). The ADA acts as civil rights legislation for families with disabilities. We must not forget the original intent of ending unjust segregation and exclusion of persons with disabilities from our "mainstream" society.

Our gratitude goes out to the thousands of people who made up the 'disability rights movement" and whose efforts have helped to change the lives of thousands of persons with disabilities today. These historical "disability advocates" sought justice in our American courts and with Congress to ensure that people with disabilities would be included in all aspects of living. Many of these advocates told their own very compelling stories of discrimination to Congress during the ADA legislative process. They succeeded by way of their unwavering commitment to help people with disabilities receive the justice they deserved (Bush).

On Friday, July 27, 2012 San Antonio Independent Living Services (SAILS) will host the 22nd Annual Americans with Disabilities Act (ADA) celebration with a theme: "honoring our veterans!" The celebration will start at about 8:30a.m.with several hundred excited supporters who will gather at San Antonio's Mercado for the Unity Pride Stroll and then over to 401 Villita for the day's events. Strollers will carry company banners along the march towards Villita where nearly 50 vendors will await their arrival. Many organizations such as our friends at AmeriGroup Corporation, Alamo Service Connection (ASC), Deaf Interpreter Services, Pride and San Antonio Lighthouse for the Blind will provide free resources for all.

A keynote speaker will share an inspirational story with everyone. SAILS will also honor the designated Disability Organization of the Year and Public Servant of the Year. Many other individuals and organizations will be recognized too. SAILS staff encourages everyone to save the date for this wonderful community event. This is the largest ADA celebration in Texas! SAILS 'Specialized Telecommunications Assistance Program (STAP) receives regular referrals from The Department of Assistive and Rehabilitative Services Independent Living Program. DARS' Independent Living Program refers consumers with many different types of disabilities for special telephones. One

such consumer, Mrs. Dora Gray, a very active Senior Citizen who lives in one of the small Texas towns that SAILS serves, received an emergency telephone through STAP. This is a great thing for Mrs. Gray who, unfortunately, broke her leg recently! Mrs. Gray also has a hearing loss and can definitely benefit from the amplification on the E.R. telephone. Mrs. Gray reports to STAP Specialist, Lori Crownover, that she is very happy with the hearing aids that DARS provided her and the amplified phone which works well with her hearing aids. Mrs. Gray, who is very involved in her church, also referred a friend to STAP who is really in need of an amplified phone.

Many consumers, like Mrs. Gray's friend, are referred to STAP or call in themselves as word gets out about the program. SAILS' STAP also receives approximately 5 to 10 referrals a month from DARS, in addition to the many other referrals from community agencies such as Social Workers As Needed, The San Antonio Lighthouse, San Antonio Housing Authority and Christian Senior Services.

Recently, SAILS received a donation of a large number of cordless phones from Haven for Hope. Many consumers are able to take advantage of these donated phones until they receive their adaptive telephones from STAP.

On January 3, 2012, Mrs. Molly Griffin called S.A.I.L.S. to inquire about the Social Security Ticket to Work program. She had become disabled in November of 2010 due to a back injury. On November 21st of 2011 she returned to work at "San Antonio Locksmith and Security". She was paid \$10.00 an hour and worked from 32 to 38 hours per week.

In mid-January her hours were not only reduced but she also switched to the "midnight shift." This made it difficult to commute because she resides 60 miles away. She considered terminating her job until I informed her that under the Social Security Work Incentives program she was entitled to deduct her mileage both to and from her place of employment. I shared with her that Social Security determines the actual mileage rate. This information was favorable because it meant that she would remain under the wage limit and permit her to retain her Social Security benefits awhile longer while she continues to seek a full time job much closer to her home.

Carol is a United States veteran who has served her country well. For more than a year she has also been a faithful participant in the Gateway to Abilities Program (GAP).

SAILS/GAP now recognizes and applauds Carol for her matriculation at San Antonio College (SAC) in the

Licensed Chemical Dependency Counselor Program (LCDCP). She stated: "I always wanted to do this, but couldn't do so until recently due to my disabilities. My goal is to get a license through the state of Texas to counsel drug and alcohol dependent persons". Carol is presently completing the course work requirements and will move on to the internship component in the near future.

When I asked her how GAP helped her to achieve this milestone, she replied: "in many ways". Case management services helped Carol to look beyond her disabilities to see her abilities. "My case manager has motivated me to become independent and to once again become a contributing member of the San Antonio community. Carol is happy that this computerized program will allow her to study at her own time and pace to insure success and to avoid failure.

I asked Carol to tell me the value of the monthly GAP classes. She responded: "they give me the resources I need to find available services". The vouchers and CPS/utilities payments through the City of San Antonio provide the financial assistance I need to meet my needs.

In conclusion, Carol praised GAP and the SAILS staff for all our programs, services and benefits. "GAP has taught me how to mold my talents into skills and abilities.

## **Access For All Includes Parking**

I recently met Craig Spradling, CTO and Co-founder of Parking Mobility. We sat down and visited about the troubles that people with disabilities have when it comes to gaining access to disabled parking. I am not a person who has to depend on a wheelchair nor do I have a physical disability. However, I manage San Antonio Independent Living Services (SAILS) so I am exposed on a daily basis to the various challenges that people in wheelchairs, in particular, have to face when it comes to accessing to all types of services. On a personal note, I have a family member that relies on a wheelchair when she wants to get out of her house. So, I was very interested in what Mr. Spradling wanted to tell me about Parking Mobility.

Parking Mobility's mission is to eliminate disabled parking abuse.

It is easier and faster for citizens of San Antonio, for example, to get involved with reporting parking violations through the use of the technology of free smart phone applications, recruitment and training of volunteers to report the abuses and the opportunity for a nonprofit or other organization to raise money while raising awareness of disabled parking abuse!
